Nominated companies will be initially screened by Texas Consilium for suitability. Those companies passing this initial screening will be invited to participate further in the evaluation and promotional process.

There is no cost to nominate. Each Nominee who passes the initial screening will be promoted by one or more Sponsors who agrees to support the Nominee's success throughout this process. As the Nominator you may also be your Nominee's Sponsor, but you will have no obligation to do so. Texas Consilium will seek sponsors to support each Nominee as needed. All approved Nominees and their Nominators and Sponsors will be recognized, with final awards presented at our Texas Consilium Business Excellence Awards Dinner.
